- 8.0 Officials shall abide by the Policies and Procedures of the BC Wheelchair Basketball Society and the BC Wheelchair Sports Association where applicable.
- 9.0 Officials shall dress in the appropriate attire.

A breach of any part of this code of conduct is sufficient grounds for an official to be withdrawn from an event and be subject to the disciplinary policies and procedures of the BC Wheelchair Sports Association as presented the association's Policy and Procedures Manual.
